PARKING ADVISORY COMMITTEE MINUTES

February 5, 2015 TOPP Room, Administration Building

The meeting was called to order by Chief Roseann Richard at 4:02 p.m.

Old Business:

I. 1/22/15 Minutes

Minutes are in progress; Ana will email a draft to members when ready.

II. Update on Proposal to President Cropper

VP Franz Lozano has received the proposal; review by President Cropper is still pending.

III. Parking Fines (Increase)

The committee continued last meeting's discussion on parking fines. The last approved increase to fines occurred in July 2008. Over the years, the State has required various fees to support the courts; at the moment, State-required court fees currently total \$12.50 per collected parking citation. We need to amend our current parking fines schedule to comply with State law and to bring us current with all CSU parking fines schedules.

To assist the committee in assessing where we are and where we want to be, CM Police staff contacted other CSU's to collect and compile information into a spreadsheet. The new sheet also includes additional information requested by committee members: the ratio of parking spaces per FTE (or per capita), ticket counts per violation type over the last year, and step increases (10, 15, and 20 percent). Roseann went over the spreadsheet. The committee reviewed the information and asked questions.

After discussion, Marc McGee made the following motion:

Adopt a 15% increase on top of the current CM fines schedule and the current \$12.50 court fees, as stated in the 4^{th} column, below:

The current citation count of 647 for **No Valid Permit Clearly Displayed** is by far the highest of all citation counts listed in the attached spreadsheet. This proposed breakdown of one general category into three will provide more meaningful data when extracting citation counts in the future. Additionally, clarifying why the citation was issued in the first place will help minimize public confusion on the subject. After discussion, Dinesh made the following motion:

Eliminate the 'No Valid Permit Clearly Displayed' violation type; in its place, add three new violation types: 'No Permit Clearly Displayed', 'Permit Expired', and 'Permit Not Valid Where Parked'.
